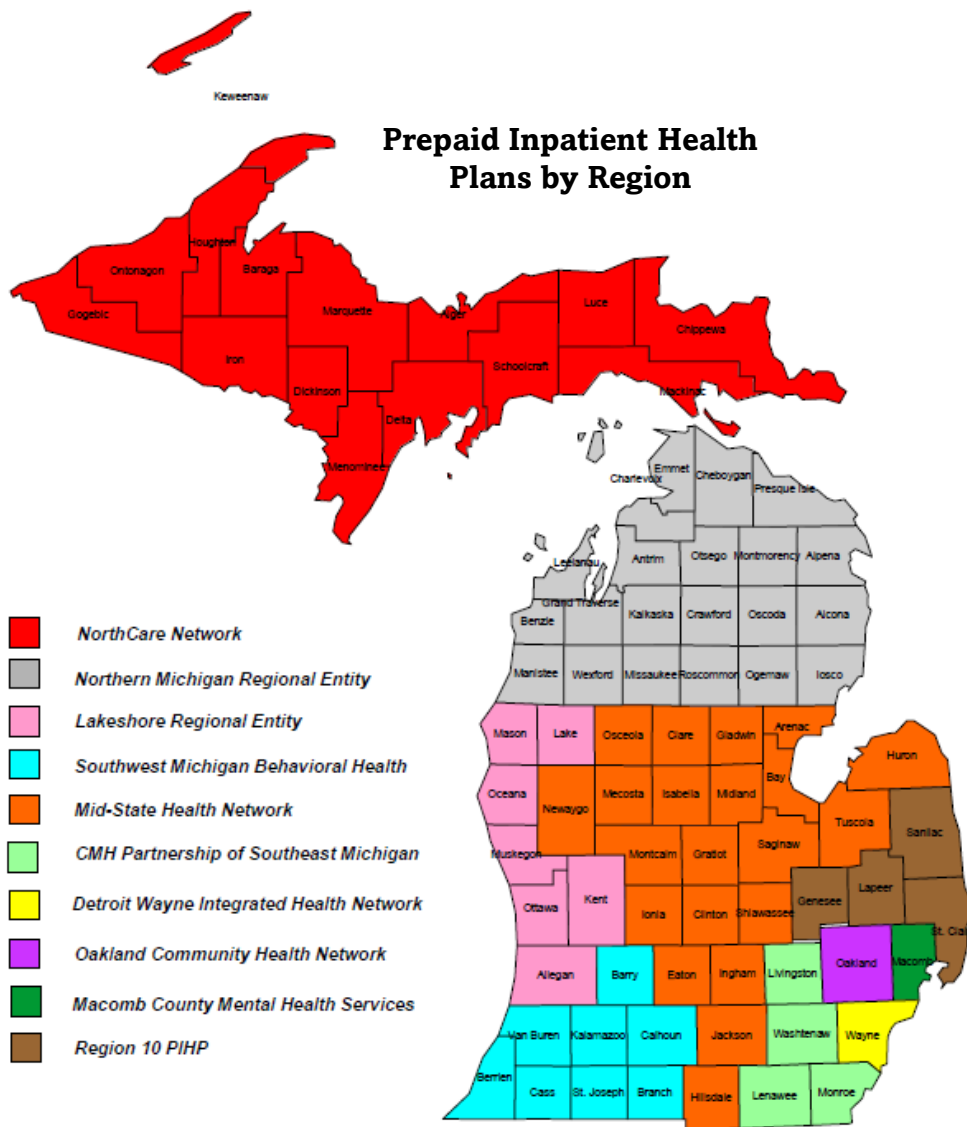

Introduction

The Community Mental Health Partnership of Southeast Michigan (CMHPSM) is one of Michigan’s ten Medicaid **Prepaid Inpatient Health Plans (PIHPs)**. CMHPSM is responsible for **Lenawee, Livingston, Washtenaw, and Monroe Counties**. CMHPSM provides oversight to the management and integration of Medicaid mental health services for adults with intellectual/developmental disabilities, serious mental illness, and children with serious emotional disturbances. In addition, the CMHPSM oversees substance use services across the four-county region including across the continuum of prevention, harm reduction, treatment, and recovery.



Substance Use Services Overview

CMHPSM Substance Use Service (SUS) Program provides regional oversight and monitoring of substance use prevention, harm reduction, treatment, and recovery programs across the [Recovery-Oriented System of Care \(ROSC\)](#). CMHPSM ensures funded programs remain in compliance with guidelines set by the Michigan Department of Health and Human Services (MDHHS), Bureau of Specialty Behavioral Health Services, Substance Use, Gambling, and Epidemiology Section (SUGE), and the Substance Abuse and Mental Health Services Administration (SAMHSA).

Program Funding

Substance Use Block Grant (SUBG)

Provided by the Substance Abuse and Mental Health Services Administration (SAMHSA), SUBG funds support the planning, implementation, and evaluation of substance use prevention and treatment programming. This funding was previously titled, the “Substance Abuse Prevention & Treatment Block Grant” (SABG). **Learn more [HERE](#).**

State Opioid Response 4 (SOR 4)

Now in its fourth cycle, SOR Grants serve to address the United States’ opioid public health crisis. SOR funds allow for increased access to medications for Opioid Use Disorder (MOUD) and support prevention, harm reduction, treatment, and recovery services for opioid misuse and opioid use disorder (OUD). SOR funding has expanded to support programs and services for stimulant misuse and stimulant use disorder (StUD). **Learn more [HERE](#).**

American Rescue Plan Act (ARPA)

ARPA Block Grant supplemental funding serves to aid economic and public health recovery in response to the COVID-19 pandemic. Public health recovery includes allocating ARPA funds to increase efforts to address behavioral health conditions related to and/or exacerbated by the pandemic. In Michigan, ARPA-funded initiatives include developing and implementing programs to address service gaps and health inequities in substance use prevention, intervention, treatment, and recovery support services. **Learn more [HERE](#).**

Public Act 206 of 1893 (PA2 Funds)

Section 24e, Paragraph 11 of Michigan’s Public Act 206 of 1893 directs, under specified circumstances, that a portion of each county’s state convention facility development fund revenue be distributed for substance use prevention and treatment programs within the county. PA2 funds are, more simply, a portion of the funds generated by state liquor taxes, diverted to each regional PIHP to be used by communities to support behavioral health programs and initiatives. **Learn more [HERE](#).**

Michigan Partnership to Advance Coalitions (MI PAC) - Partnership For Success (PFS)

In 2022, Michigan received a federal PFS grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). This 5-year grant inspired the MI PAC project. MI PAC ensures community substance use prevention coalitions have increased technical assistance and capacity building resources so they can better meet their missions. MI PAC funds also increase coalition capacity to focus efforts on addressing community health disparities. In Region 6, one coalition per county receives MI PAC funding to work together on a Regional Coalition to Address Health Disparities. **Learn more [HERE](#).**

Program Types Overviews

The types of programs and initiatives funded by CMHPSM's Substance Use Services program are informed by the Substance Abuse and Mental Health Services Administration's (SAMHSA) [Recovery-Oriented Systems of Care](#) (ROSC) model, SAMHSA's [Strategic Prevention Framework](#) (SPF), and the National Academy of Medicine's (formerly the Institute of Medicine) [Continuum of Care](#). The aim is to ensure Region 6 programs serving individuals across the continuum of care – from prevention to harm reduction to treatment, and recovery – are not only supported fiscally, but also through technical assistance, monitoring, and evaluation.

Prevention

Prevention programming aims to provide the knowledge and skills to individuals, groups, and communities necessary to prevent the development of adverse health behaviors and/or the onset of a substance use disorder. Programs focus on the reduction of relevant risk factors and/or the growth of protective factors. Using the [Strategic Prevention Framework](#) (SPF), prevention programs address one or more of the following priority areas: (1) reduce childhood and underage drinking; (2) reduce prescription and over-the-counter drug use/misuse; (3) reduce youth access to tobacco and nicotine; and (4) reduce illicit drug use.

Engagement Centers

Engagement Centers (ECs) are short-term, drop-in crisis intervention facilities. ECs offer a variety of services and resources to individuals with substance use and co-occurring needs. Offerings generally include meeting basic needs (meals, showers, safe sleep areas, etc.), holding group meetings and social activities, connecting individuals to longer-term services, and more. ECs also serve to reduce the strain on hospital emergency rooms by providing an alternative option for community members in need of immediate, behavioral health-related care by specially trained staff.

Harm Reduction

Harm Reduction programs and initiatives address individual and community-level substance use issues through a variety of strategies aimed at reducing the physical and social harms substance use may cause. At the individual level, harm reduction strategies work to “meet people where they are” and provide options for health and safety resources. Because many harm reduction programs center on decreasing stigma and maintaining engagement with individuals in active use, these programs may serve as a bridge to treatment and recovery services.

Jail-Based MAT/MOUD

Jail-based programs with Medication-Assisted Treatment (MAT) and Medications for Opioid Use Disorder (MOUD) provide medication and supportive services to individuals with Opioid Use Disorder (OUD) while they are in jail. Jail-based MAT/MOUD program staff also work closely within the discharge planning process to ensure continuity of care post-release and decrease overdose risk of program participants.

Substance Use Disorder (SUD) Treatment

SUD treatment providers offer a range of services including withdrawal management, outpatient and intensive outpatient treatment residential treatment, and medications for substance use disorders. Many providers also offer [Women's Specialty Services](#) (WSS). WSS are specialized services tailored to meet the needs of primary caregivers and their children. Pregnant and postpartum women are a priority for admission to treatment.

Additionally, some SUD treatment providers offer medication-assisted treatment (MAT)/medications for Opioid Use Disorder (MOUD) services. MAT/MOUD services include FDA-approved medications that have been demonstrated to be safe and effective for Opioid Use Disorder or Alcohol Use Disorder (AUD) treatment. Currently, the three FDA-approved MAT/MOUD medications are buprenorphine, methadone, and naltrexone. Not all treatment providers offer all MAT/MOUD medication options. *See the “Treatment Providers” section of this document to learn more.*

Substance Use Disorder Health Homes (SUDHH)

[SUD Health Homes](#) provide person-centered, comprehensive care coordination for qualifying individuals with a diagnosed Opioid Use Disorder (OUD), Stimulant Use Disorder (StUD), or Alcohol Use Disorder (AUD). Participants engage with an interdisciplinary team of professionals – including peer support specialists, community health workers, and clinicians – to develop and implement a unique care plan.

Recovery and Peer Support

Recovery services provide individuals with the resources and support needed to achieve treatment goals and sustain substance use recovery. Recovery is a complex, personal journey that emphasizes a need for comprehensive health care, community, a safe home, and self-determined purpose. [Peers](#) are individuals with lived experience who have undergone specialized training and certification so they can engage in the work of supporting others in their treatment and recovery journey.

Program: Student Prevention Leadership Teams (SPLT)

Description: SPLT is a peer-to-peer substance use prevention program based on the Ohio Youth Led Prevention Network Model. SPLT prevention initiatives provide students with education on underage drinking, prescription and over the counter drugs, marijuana, tobacco, and nicotine. SPLT is currently offered in Monroe County middle and high schools.

Program: Wellness Initiative for Senior Education (WISE)

Description: Wellness Initiative for Senior Education (WISE) is a wellness and prevention program that targets older adults and celebrates healthy aging by educating on a variety of topics including safe medication use, the aging process, communicating effectively with healthcare professionals, and strategies for making healthy lifestyle choices.

Program: Botvin LifeSkills Training

Description: The Botvin LifeSkills Training Middle School program is a groundbreaking substance use and violence prevention program based on more than 35 years of rigorous scientific research. Proven to be the most effective evidence-based program used in schools today, Botvin LifeSkills Training is designed to promote mental health and positive youth development. In addition to helping youth resist drug, alcohol, and tobacco use, the LifeSkills Training Middle School program also effectively supports the reduction of violence and other high-risk behaviors. This program is aligned to the National Health Education standards and to CASEL's social and emotional learning (SEL) competencies.

Program: Prime for Life

Description: Prime For Life is an evidence-based motivational prevention, intervention, and pre-treatment program specifically designed for people who might be making high-risk choices. This includes impaired driving offenders, college students, and young people charged with alcohol and/or drug offenses. It is designed to change drinking and drug use behaviors by changing beliefs, attitudes, risk perceptions, motivations, and the knowledge of how to reduce their risk of alcohol- and drug-related problems throughout their lives.

Program: Prevention Theater Collective (PTC) - Botvin LifeSkills Transitions

Description: PTC is a theatre-based peer-to-peer outreach program designed to shift attitudes and behaviors around drug and alcohol use subsequently improving the overall health and wellness in Washtenaw County area high schools. PTC frames its approach around Botvin LifeSkills Training (LST) Transitions. PTC is a highly interactive, skills-based curriculum designed to promote positive health and personal development.

Program: Designated Youth Tobacco Use Representative (DYTUR)

Description: Designated Youth Tobacco Use Representatives (DYTUR) conduct activities mandated by the federal Synar Amendment and Michigan's Youth Tobacco Act. The program's aim is to ensure tobacco retailers are not selling tobacco products to underage youth and limit youth access to tobacco products in our communities. DYTUR efforts are significant as their outcomes are directly related to the amount of funding received by the State of Michigan for Substance Use Disorder efforts.

Program: Tobacco/ENDS Regional Program

Description: Karen Bergbower & Associates (KBA) works to decrease the number of ENDS (electronic nicotine delivery systems) products in schools across the region. The goal for KBA is to recruit and train youth and community partners to work with schools to strengthen substance-free/tobacco-free/smoke-free policies to include nicotine, e-cigarettes, and related vaping paraphernalia.

Program: Communities Mobilizing for Change on Alcohol (CMCA)

Description: CMCA is an evidence-based program that mobilizes communities to take action on underage drinking. It is designed to improve public health of communities by changing institutional policies, procedures, and practices, to reduce the flow of alcohol to youth under 21.

Program: Curriculum-Based Support Groups (CBSG)

Description: CBSG is an evidence-based prevention program for children and youth at elevated risk for substance use, delinquency, and violence. CBSG curriculum consists of a combination of substance use prevention, youth development, coping, and social skills units. Programming is provided to small numbers of children and youth in highly structured educational support groups.

Program: Project SUCCESS (Schools Using Coordinated Community Efforts to Strengthen Students)

Description: Project SUCCESS is a model program that prevents and reduces adolescent substance use by using interventions that have proven effective in reducing risk factors and enhancing protective factors. Highly trained professionals are placed in each Livingston County public middle and high school, two alternative schools, and one charter school to provide a full range of substance use prevention and early intervention services. Services include individual intervention, group invention, prevention education discussions and programs, training programs, and consultation on prevention issues with school staff, and referrals/follow-ups as needed.

Program: Youth Led Prevention (YLP)

Description: YLP is a comprehensive program for youth that engages educators, parents, and communities by combining environmental prevention strategies and individual prevention strategies to support the positive attitudes, choices, and behaviors of youth.

Program: Parents as Teachers

Description: In this evidence-based program, “Parent Educators” provide support and education to families with a child 0-3 who has been prenatally or postnatally exposed to alcohol, tobacco, or other drugs. This curriculum is implemented by Parent Educators during personal visits with the family. During each visit, Parent Educators focus on family well-being, parent/child activities that promote healthy

development, and developmental centered parenting topics. Families also can participate in group connections. Children’s development and progress toward developmental goals and parental attitudes are assessed and monitored.

Program: Project SUCCESS (Schools Using Coordinated Community Efforts to Strengthen Students)

Description: Project SUCCESS is a model program that prevents and reduces adolescent substance use by using interventions that have proven effective in reducing risk factors and enhancing protective factors. Highly trained professionals are placed in schools to provide a full range of substance use prevention and early intervention services. Services include individual intervention, group invention, prevention education discussions and programs, training programs, and consultation on prevention issues with school staff, and referrals/follow-ups as needed. Program: SRSLY Chelsea

Description: SRSLY Chelsea is a youth-led substance use prevention coalition, with adult input and support. SRSLY Chelsea’s purpose is to empower youth to live healthy, substance-free lives by bringing the community together and supporting youth mental health. SRSLY Chelsea is managed through the Chelsea Hospital Community Health and Well-being (CHWB) service line. The purpose of the SRSLY Chelsea coalition is to provide local youth and families with mental health support and prevent youth substance use. SRSLY Chelsea is a youth-led community coalition comprised of a High School Student Leadership Team and Adult Volunteer Team that support youth-developed activities, resource development and family programming.

Program: SRSLY Dexter

Description: SRSLY Dexter is a youth-led substance use prevention coalition, with adult input and support. SRSLY Dexter’s purpose is to empower youth to live healthy, substance-free lives by bringing the community together and supporting youth mental health. SRSLY Dexter is managed through the Chelsea Hospital Community Health and Well-being (CHWB) service line.

Program: Project SUCCESS (Schools Using Coordinated Community Efforts to Strengthen Students)

Description: Project SUCCESS is a model program that prevents and reduces adolescent substance use by using interventions that have proven effective in reducing risk factors and enhancing protective factors. Highly trained professionals are placed in schools to provide a full range of substance use prevention and early intervention services. Services include individual intervention, group intervention, prevention education discussions and programs, training programs, and consultation on prevention issues with school staff, and referrals/follow-ups as needed. Program: Comprehensive Community Approach to Youth SUD (CCAYS)

Description: CCAYS applies harm reduction values to its approach to offering treatment and related substance use services for young people within various stages of change across the following categories: integrated care/treatment models and youth outreach. The program can briefly be understood as: CCAYS re-envisioning how to bring SBIRT to youth who are hesitant to reduce use or abstain from using substances through a novel, tablet-based screening and educational tool. Developed by Henry Ford Health researchers, iHeLP uses psychoeducation, branching logic, and technology to tailor a brief intervention to each young person's particular stage of change. Optional texting allows for customized follow-ups with young people to encourage them on their stage of change journey. Corner's health educator, community therapist, and Theatre Troupe will take iHeLP tablets with them to youth sober events and other community settings, local schools, and venues that are comfortable to young people to reach them and drive home the lessons that the Corner's Theatre Troupe will perform related to substance use disorder, hesitancy, and youth-centered decision-making around abstinence and quitting.

Program: Lenawee Substance Abuse Prevention Coalition

Description: Lenawee Substance Abuse Prevention Coalition (LSAPC) follows Strategic Prevention Framework activities. This includes engaging with the Community Health Assessment planned; hosting coalition meetings and trainings to build capacity and relationships with representatives; supporting schools with identifying, evaluating, and implementing prevention programs; and promoting strength-based health behaviors. LSAPC has a goal to expand efforts to include identifying tangible support for youth prevention programs, events, and school-based activities; re-invigorating community-based evaluation strategies; and updating and expanding the distribution of prevention marketing materials.

Program: Livingston County Community Alliance (LCCA)

Program: Monroe County Substance Abuse Coalition

Description: The MCSAC focuses on reducing childhood and underage drinking, reducing prescription and over the counter drug use and misuse, reducing youth access to tobacco and nicotine, and reducing illicit drug use. The coalition identifies consequences associated with each of these areas. Modifiable risks and protective factors are then addressed. MCSAC utilizes the Community Anti-Drug Coalitions of America's (CADCA's) 7 Strategies for Community Change.

Michigan Partnership to Advance Coalitions

Each of Region 6's four counties receive *Michigan Partnership to Advance Coalitions* (MI PAC) funding. Using the Strategic Prevention Framework (SPF), the focus of the MI PAC project is strengthening state and community-level prevention capacity to identify and address local substance use prevention concerns around tobacco, e-cigarettes, and marijuana. Regional participants include the Lenawee Substance Abuse Prevention Coalition, the Livingston County Community Alliance, the Monroe County Substance Abuse Coalition, and the Washtenaw Prevention Coalition. A regional collaborative around health disparities will be developed.

Program: Saint Joseph Center of Hope Engagement Center

Description: Saint Joseph Center of Hope Engagement Center (EC) provides a 23-hour crisis intervention facility, staffed by trained peer recovery and family coaches offering comprehensive support. Trained peers in addiction support work with the individual(s) in active addiction to help them navigate their immediate crisis needs and offer necessary resources. Providing a supportive and stable environment, including monitoring of vitals, assistance with personal hygiene, and three nutritious meals daily, as well as a comfortable bed, while working collaboratively offering appropriate community resources and addiction recovery treatment options. The EC offers referrals to all who come seeking help, regardless of their readiness to engage with addiction support services. Our referrals come from a diverse range of sources, including community resources, law enforcement agencies, and medical facilities, as well as friends and family members. The EC provides a comprehensive solution to prevent burnout among hospital and criminal justice system personnel, promoting a secure and supportive environment for those struggling with addiction.

Program: Engagement Center

Description: The Engagement Center (EC) is a 9-bed crisis intervention facility that provides a community-supervised, supportive setting for acutely intoxicated, impaired individuals who are experiencing a crisis due to a substance use disorder. It is an alternative to hospital emergency room care for those who require observation for safety. Objectives of the EC include harm reduction, creating a welcoming environment, meeting individuals where they are at, linking to recovery community and treatment, case management, mental health, medical, and other needed services.

Program: Pathways Engagement Center

Description: Pathways Engagement Center is an after-hours, recovery-based program in Lenawee County. It provides a warm, welcoming environment in which adults with substance use and co-occurring needs can receive support, advocacy, recovery planning, and referrals during times when most resources are unavailable.

Program: Stepping Stones Engagement Center

Description: The Stepping Stones Engagement Center (EC) provides a warm, welcoming, and safe environment for individuals who may be detoxing from substances and/or seeking supports to promote their recovery journeys. Services begin with engagement and conversation. Groups are offered daily sessions on topics such as Coping Skills, Friends and Family Support, Relapse Prevention, Smart Recovery, and Veteran support. Additionally, sober social activities are offered including food and game nights, recovery speakers, barbeques, and holiday gatherings. The EC provides recovery supports to adult Livingston County residents and their families.

Program: Harm Reduction & Integrated Care

Description: This program focuses on individuals with complex and co-occurring behavioral and physical health challenges who have experienced homelessness including substance use. This program consists of social workers, community builders, and peer support specialists who provide outreach and assertive engagement in the context of recovery-oriented principles. The aim is to connect with individuals at all stages of change in the community and in their homes offering education, harm reduction support, and linkage to needed services.

Program: St. Joseph Center of Hope – Overdose Education & Naloxone Distribution

Description: St. Joseph Center of Hope Engagement Center (EC) located on ProMedica Hospital Campus in Monroe allows for a collaborative approach to addressing addiction crises. The EC is accessible 24/7, including all holidays, and offers inclusive training on naloxone utilization to reverse opioid effect and prevent overdoses to all community members. To promote public health and safety, the EC provides Monroe County with access to naloxone save-a-life stations, xylazine and fentanyl testing strips, all aimed to reducing harm and promoting overall well-being.

Program: Harm Reduction & Community Outreach – Overdose Education & Naloxone Distribution (OEND)

Description: The goal of Lenawee CMHA Harm Reduction & Community Outreach program is to reduce the impact of substance use in Lenawee County by educating professionals and people actively using substance on stigma and harm reduction, provide life-saving resources such as Narcan and fentanyl test strips, and increase awareness of community resources and supports. The Lenawee CMHA Harm Reduction & Community Outreach program uses a Certified Peer Recovery Coach to conduct daytime

outreach to individuals currently using substances and the professionals who serve this population. It includes providing OEND, advocating for harm reduction, reducing stigma, and connecting people to community resources.

Program: Overdose Education & Naloxone Distribution (OEND)

Description: Livingston CMHA provides opioid overdose education and naloxone (Narcan) kits free of charge to Livingston County residents through the Engagement Center, jail, the Project ASSERT program, community outreach/education events, and more. Additionally, Livingston CMHA provides harm reduction tools including fentanyl and xylazine test strips to individuals at risk. Naloxone is also disseminated to the community via a naloxone vending machine stewarded by Livingston CMHA.

Program: Overdose Education & Naloxone Distribution (OEND)

Description: The University of Michigan OEND program supports the community by providing overdose education and distribution of harm reduction supplies such as naloxone, test strips, and xylazine wound care kits. The University of Michigan conducts training sessions with community members in Region 6 to provide education and resources, facilitates the implementation and maintenance of naloxone vending machines and distribution boxes in community settings and healthcare facilities. The University of Michigan also develops educational resources on safer use practices and strategies for accessing care.

Program: Harm Reduction/Syringe Services Program (SSP)

Description: Home of New Vision Harm Reduction (HNV-HR) promotes harm reduction practices by providing naloxone, fentanyl and xylazine test strips, safer-use supplies, basic wound care, and Hepatitis C testing to people who use drugs (PWUD) regardless of socioeconomic or immigration status. Using non-coercive and non-judgmental strategies, HNV-HR strives to reduce the harmful effects of overdose, limit the spread of disease, and mitigate the risks associated with substance use.

The program ensures maintenance of medications for individuals entering jail who are currently prescribed medication for opioid use disorder or initiate treatment for opioid use disorders during jail incarceration for individuals with an opioid use disorder not previously engaged in treatment. These services work on engaging individuals who may not otherwise have access or seek treatment and facilitate continuity of treatment for opioid use disorder post-release.

Program: Project ASSERT at St. Joseph Center for Hope

Description: Project ASSERT is a nationally recognized, evidence-based program aimed at addressing substance use disorders for emergency room patients through timely screening, brief intervention, and referral services, ultimately leading to successful outcomes. Project ASSERT program embeds trained peer recovery coach at ProMedica Regional Hospital, providing an innovative alternative to traditional patient care, emphasizing support in recovery, reducing stigma, and increasing successful paths to recovery.

Program: Recovery Court Peer

Description: The Recovery Court Peer program works with treatment courts in Washtenaw County to support clients by participating in weekly team meetings, and regular care coordination. New participants in 14B District Recovery Court are connected with the Recovery Court Peer program for services. Individuals begin enrollment in the program and become connected with a Recovery Support Specialist. The Recovery Court Peer program meets with participants through a combination of in-person meetings, phone calls, and telehealth services. Engagement with participants continues until they complete 14B Recovery Court.

Program: Recovery Housing

Description: In Dawn Farms Recovery Housing Program, clients who have children can live with their children in their own apartment while learning new skills and building healthy relationships in recovery. These parents will act as peer supports for one another, with support from a House Manager and parenting support group leaders, while children in the program also have an opportunity for community-building among themselves. This unique program removes the barrier, expands recovery support and makes the program accessible to a group of people who are traditionally not accommodated in recovery housing. These residents are supported by a Strong Roots parenting group, one-on-one sessions with Recovery Support Specialists, and connections with community resources as needed.

Description: Recovery Overdose Outreach Team (ROOT) is a community-based program that engages individuals who have experienced opioid overdoses. Through collaboration with law enforcement, EMS, and healthcare providers, ROOT offers outreach, intervention, and follow-up support for up to 90 days post-discharge.

Description: Project ASSERT is a nationally recognized, evidence-based program using motivational interviewing to encourage individuals and family members to seek care for use of substances. Project ASSERT peer recovery coaches provide screening, brief intervention and referrals to individuals with potential substance use at the hospital emergency room. Project ASSERT was implemented with Trinity Livingston Hospital in spring 2023 after many years of collaboration and interruption by the pandemic. Program: Epidemiologist

Description: The epidemiologist studies and evaluates opioid treatment by gaining data on the supports and barriers through consumer focus groups. The epidemiologist will provide directions to prevention and treatment expansion efforts. This program provides scientific advice and technical assistance for community health assessments, program evaluation, research, presentations, publications, and other related requests.

Program: Livingston CMH Wraparound Services

Description: Wraparound is a service specific for youth and families involved and engaged with multiple service providers, including SUD. Description: This specific Anchor Institution provides a health hub specifically for Accessing Substance Use/Behavioral Health Program for communities experiencing health disparities. This Anchor Institution works specifically with African American and Hispanic/Latino/a/x members of the community. The location is within the Family Medical Center of Michigan. Within this location is a kiosk that provides a substance use disorder /behavioral health assessment for participants. This assessment will be presented in English and Spanish.
