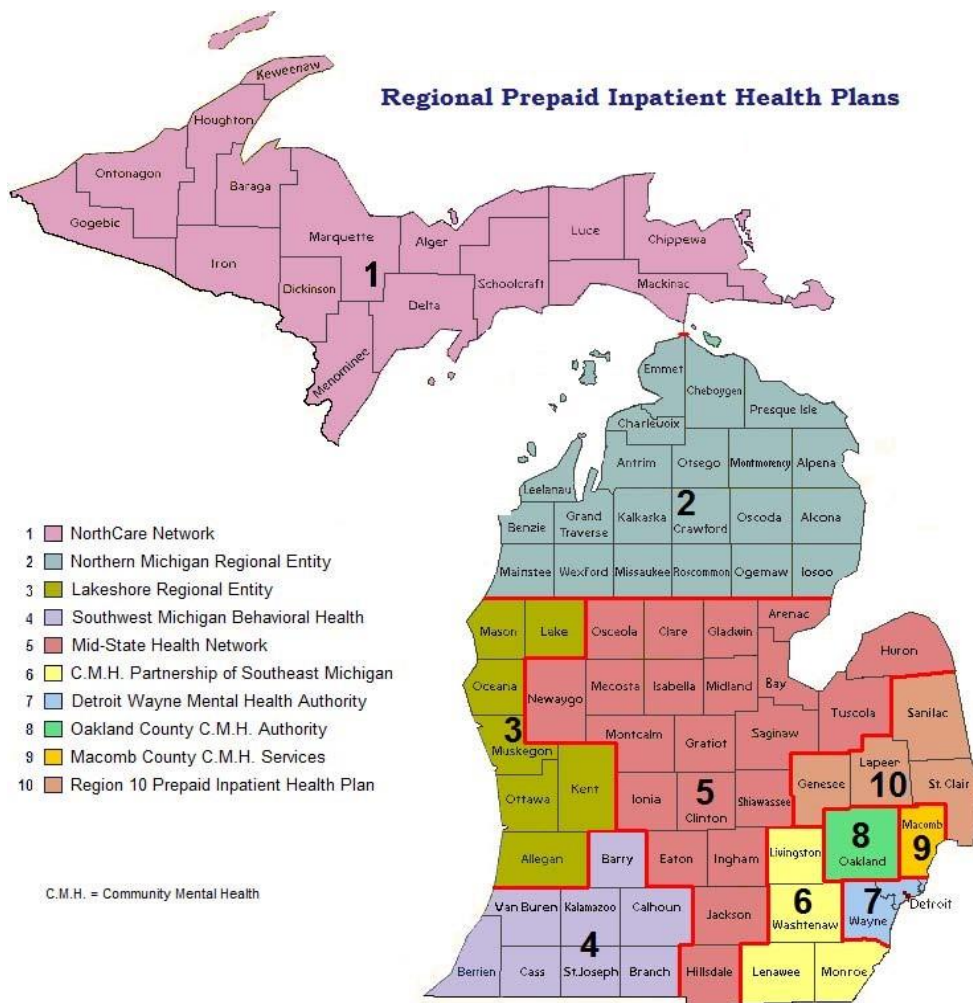

Introduction to CMHPSM

The Community Mental Health Partnership of Southeast Michigan (CMHPSM) is one of Michigan’s ten Medicaid **Prepaid Inpatient Health Plans** and is responsible for the counties of **Lenawee, Livingston, Monroe, and Washtenaw**. CMHPSM (Region 6) provides oversight of the management and integration of Medicaid mental health services for adults with intellectual/developmental disabilities, serious mental illness, and children with serious emotional disturbances. In addition, the CMHPSM oversees substance use disorder services across the four-county region. Mental Health Services are delivered through the Community Mental Health Service Providers in each respective county: Lenawee Community Mental Health Authority, Livingston Community Mental Health Authority, Monroe Community Mental Health Authority and Washtenaw County Community Mental Health Agency.



CMHPSM Substance Use Services

CMHPSM provides regional oversight and monitoring of substance use prevention, harm reduction, treatment and recovery programs across the continuum of care. CMHPSM ensures compliance with guidelines set by the Michigan Department of Health and Human Services (MDHHS), Bureau of Specialty Behavioral Health Services, Substance Use, Gambling, and Epidemiology Section (SUGE).

Prevention providers utilize the Strategic Prevention Framework (SPF) to guide decisions and create a comprehensive plan. Prevention programs address one or more of the following priority areas: (1) reduce childhood and underage drinking; (2) reduce prescription and over the counter drug abuse/misuse; (3) reduce youth access to tobacco and nicotine; and (4) reduce illicit drug use.

Engagement Centers are drop-in centers with after-hours availability offering a variety of supportive services and resources for people who use drugs including direct connections to substance use treatment services if and when they are ready, and peers to support their recovery pathways.

Harm Reduction is an approach to addressing substance use incorporating a spectrum of strategies to meet people “where they are” on their own terms, and may serve as a pathway to additional prevention, treatment, and recovery services.

Jail-Based MAT/MOUD programs provide medication and supportive services to individuals with Opioid Use Disorder in jails, and connects them to resources upon discharge in the community.

SUD Treatment providers offer a range of services and levels of care including withdrawal management/detox, outpatient/intensive outpatient and residential treatment, women’s specialty services, and medication assisted treatment/medication for Opioid Use Disorder.

Opioid Health Homes provide integrated, person-centered, and comprehensive care coordination to individuals with an Opioid Use Disorder (OUD).

Recovery and Peer Supports include a spectrum of services supporting substance use disorder recovery, such as Recovery Housing, Recovery Community Organizations, and Peer Recovery services.

Catholic Charities of Southeast Michigan	Monroe	Student Prevention Leadership Teams (SPLT)	SPLT is a peer-to-peer substance use prevention program in 23 Monroe County High Schools and Middle Schools and is based on the Ohio Youth Led Prevention Network Model. The SPLT prevention initiatives provide students with education on underage drinking, prescription and over the counter drugs, marijuana, tobacco, and nicotine.
Catholic Social Services of Washtenaw County	Washtenaw	Get Connected	Get Connected is an evidenced- based prevention program for older adults. The curriculum provides education and linkage to resources on medication, alcohol, and mental health.
		CAGE Screenings	CAGE Screenings are used to help identify risk factors and signs of substance use/misuse in older adults. Referrals are provided as needed.
Eastern Michigan University Engage @ EMU	Washtenaw	Prevention Theatre Collective (PTC) Botvin Lifeskills Transitions	PTC is a theatre-based peer to peer outreach program designed to shift attitudes and behaviors around drug and alcohol use subsequently improving the overall health and wellness in Washtenaw County area high schools. PTC frames its approach around Botvin LifeSkills Training (LST) Transitions which is a highly interactive, skills-based curriculum designed to promote positive health and personal development.
		Prime For Life	Prime For Life is an evidence-based motivational prevention, intervention and pre-treatment program specifically designed for people who might be making high-risk choices. This includes impaired driving offenders, college students, and young people charged with alcohol and/or drug offenses. It is designed to change drinking and drug use behaviors by changing beliefs, attitudes, risk perceptions, motivations, and the knowledge of how to reduce their risk of alcohol- and drug-related problems throughout their lives.
		Botvin's LifeSkills Training	The Botvin LifeSkills Training Middle School program is a groundbreaking substance abuse and violence prevention program based on more than 35 years of rigorous scientific research. Proven to be the most effective evidence-based program used in schools today, LifeSkills Training is comprehensive, dynamic, and developmentally designed to promote mental health and positive youth development. In addition to helping youth resist drug, alcohol, and tobacco use, the LifeSkills Training Middle School program also effectively supports the reduction of violence and other high-risk behaviors.

Jefferson Schools	Monroe	Student Assistance Program Catch My Breath	Jefferson schools program provides this evidenced Based model to explore the risks and consequences of vaping from the "Catch My Breath" curriculum as well as other assignments/discussions from SAMHSA and NIDA. This program provides another level of restorative justice to create a safe and supportive space for students who have received a suspension for vaping in the Middle School and the High School. Other students are encouraged to complete the program/curriculum by parent request or at their own will. This program is available to any 5 th -12 th grade Jefferson student, but a requirement for those with vaping infractions. Materials for parents are also provided.
Karen Bergbower & Associates	Lenawee Livingston Monroe Washtenaw	Designated Youth Tobacco Use Representative (DYTUR)	Designated Youth Tobacco Use Representatives (DYTUR) conduct activities mandated by the federal Synar Amendment and Michigan's Youth Tobacco Act to ensure tobacco retailers are not selling tobacco products to underage youth and limit youth access to tobacco products in our communities. DYTUR efforts are significant as their outcomes are directly related to the amount of funding received by the State of Michigan for Substance Use Disorder efforts.
Livingston County Catholic Charities	Livingston	Communities Mobilizing for Change on Alcohol (CMCA)	CMCA is an evidence-based program that mobilizes communities to take action on underage drinking. It is designed to improve the public health of communities by changing institutional policies, procedures, and practices, to reduce the flow of alcohol to youth under 21.
		Curriculum-Based Support Groups (CBSG)	CBSG is an evidence-based prevention program for children and youth who are at elevated risk for substance use/abuse, delinquency and violence. CBSG curriculum consists of a combination of substance abuse prevention, youth development and coping and social skills education to small numbers of children and youth in highly structured educational support groups.
		Project SUCCESS (Schools Using Coordinated Community Efforts to Strengthen Students)	Project SUCCESS is a model program that prevents and reduces adolescent substance use and abuse by using interventions that have proven effective in reducing risk factors and enhancing protective factors. Highly trained professionals are placed in each Livingston County public middle and high school as well as two alternative schools and one charter school to provide a full range of substance use prevention and early intervention services (individuals, groups, prevention/education discussions and programs, trainings, and consultation on prevention issues with school staff, and referrals and follow-ups as needed).

Livingston County Catholic Charities	Livingston	Youth Led Prevention (YLP)	YLP is a comprehensive program for youth that engages educators, parents, and communities by combining environmental prevention strategies and individual prevention strategies to support the positive attitudes, choices and behaviors of youth in a community.
Monroe County Intermediate School District	Monroe	Nurturing Parenting Parents as Teachers	Parent Educators provide support and education to families with a child 0-3 who has been prenatally or postnatally exposed to alcohol, tobacco or other drugs. An evidence-based curriculum is implemented during personal visits with the family. During each visit Parent Educators focus on family well-being, parent/child activities that promote development, and developmental centered parenting topics. Families also have the opportunity to participate in group connections. Children's development and progress toward developmental goals is assessed and monitored on-going, as are parental attitudes.
Paula's House	Monroe	Celebrating Families	Celebrating Families is a curriculum to facilitate recovery for parents and children impacted by alcohol and/or substances. The program utilizes a family coach who works with women and their children throughout the week on issues impacting their relationship, their recovery or topics the women are interested in addressing.
St. Joseph Mercy Chelsea Hospital	Washtenaw	Project SUCCESS (Schools Using Coordinated Community Efforts to Strengthen Students) Chelsea Lincoln Manchester	Project SUCCESS is an evidence-based program that prevents and reduces adolescent substance use and abuse. It places a Project SUCCESS Counselor in the middle school and high school to provide individual and group counseling, prevention education in classrooms, to train/consult school staff on prevention issues, coordinate the substance use services and policies of the school and refer and follow-up with students and families needing substance use treatment or mental health services in the community.

This includes the Lenawee Substance Abuse Prevention Coalition, the Livingston County Community Alliance, the Monroe County Substance Abuse Coalition, and a new coalition being developed in Washtenaw County. A regional collaborative around health disparities will be developed.

SJCOH is an accredited CARF Crisis Intervention Center which provides supervised, supportive setting for individuals with substance use disorders and/or experiencing a mental health crisis. SJCOH also provides peer support and transitions to appropriate treatment and/or recovery resources within the Monroe community.
Home of New Vision	Washtenaw	Engagement Center	The Engagement Center (EC) is a crisis intervention facility that provides a community based supervised, supportive setting for individuals with substance use and co-occurring disorders. It is an alternative to hospital emergency room care for those who require observation for safety in a setting that provides a needs assessment and immediate stabilization and active linkage to recovery and community resources.
Lenawee CMHA	Lenawee	Pathways Engagement Center	Pathways Engagement Center offers recovery supports to individuals experiencing SUD in Lenawee County through existing after-hours programming, sober events and daytime outreach.
Livingston CMHA	Livingston	Stepping Stones Engagement Center	The Engagement Center provides a warm, welcoming and safe environment for individuals who may be detoxing from substances and/or seeking supports to promote their recovery journeys. Services begin with engagement and conversation. Groups are offered daily on topics such as Coping Skills, Friends and Family Support, Relapse Prevention, Smart Recovery, and Veteran support. Additionally, sober social activities are offered with food and game nights, recovery speakers, barbeques and holiday gatherings. The Engagement Center provides recovery supports to adult Livingston County residents and their families.

This program consists of social workers, community builders and peer support specialists that provide outreach and assertive engagement in the context of recovery-oriented principles to connect with individuals at all stages of change in the community and in their homes offering education, harm reduction support, and linkage to needed services.
		SUD Health Home	This is a pilot program that focuses on comprehensive care management and coordination services with an opioid use disorder. This program functions as the central point of contact for directing patient centered care across the broader health care system. The model will also elevate the role and importance of Peer Recovery Coaches and Community Health Workers to foster direct empathy and raise overall health and wellness.

The program implements an evidence-based Screening, Brief Intervention, and Referral to Treatment (SBIRT) model to identify opportunities to work with youth, reduce use and risk, prevent substance misuse and prevent dependence on alcohol and illicit drugs.
Unified HIV Health & Beyond	Washtenaw	Community Outreach and Harm Reduction	This program's primary goal is the prevention from overdose and infectious disease transmission, while improving the physical, mental and social wellbeing of participants. This includes encouraging them to seek substance use disorder treatment and recovery by attending Wellness Harm Reduction support groups, overdose prevention training and implementing safe use practices.

The peer recovery coach engages individuals while incarcerated, provides support while the individuals participate in the Jail MAT/MOUD program and assists with community re-entry. Additionally, the peer recovery coach prioritizes relationship-building at every stage and encourages program participants to use Pathways Engagement Center as an ongoing resource and support.
Monroe CMHA	Monroe	Jail-Based MAT	The Monroe County Jail-Based MAT program has embedded multiple evidence-based practices to assure persons with OUD who are booked into jail receive the standard of care during incarceration, with the ultimate goal of reducing overdose deaths post release. The Monroe County Jail-Based MAT program incorporates the four strategies outlined for MOUD model implementation, including 1) use of validated screening tools, 2) access to all three forms of MOUD, 3) provision of psychosocial services, and 4) a continuity of care plan with naloxone distribution on release.

Therapeutics' multi-disciplined approach to recovery is supported by the integration of Cognitive Behavior Therapy, Motivational Interviewing, Contingency Management, and Mindfulness with the appropriate medication to achieve successful client outcomes.

Services include MAT prescribing, drug testing, counseling, and interactive online recovery courses. Individuals have access to 1:1 sessions with their medical provider, recovery coach and counselor as well as group sessions and chat-based communication with a care team.

AACTC provides quality care in an atmosphere of dignity and respect. They believe one of the most significant components of care is the personalized treatment plans, which are started at initial intake appointments. Their team of experts will ask you questions about your medical history, administer some basic tests such as a physical exam, and discuss what you hope to accomplish in your time in OHH.

		Recovery Support Services	The Recovery Support Services (RSS) program at CCSEM is structured to provide individuals receiving outpatient substance use treatment services with case management and peer recovery support. The program provides additional support to individuals receiving SUD treatment to reduce barriers, improve rates of successful completion of treatment and establishes a pathway to sustained recovery.
Dawn Farm	Washtenaw	Recovery Court Peer	Recovery Court Peer will meet with program participants through in person meetings, phone calls, and telehealth services. This program maintains engagement with participants until they complete 14B Recovery Court successfully, indicating stable recovery and positive legal status.
	Lenawee Livingston Monroe Washtenaw	Recovery Support Services	Dawn Farm Recovery Support Specialists provide elements of traditional peer support services, support and case management for clients diagnosed with moderate to severe OUD and StUD. Activities include locating and linking clients to community resources that support recovery, including individuals and groups within the recovering community; provide hope, emotional support, and motivational support; provide assertive engagement to individuals during periods of elevated vulnerability; help clients advocate for themselves where barriers to recover are encountered; provide crisis management and connecting clients with other services as appropriate; link clients with MOUD prescribers and address barriers to accessing MOUD; and help clients identify recovery barriers and capital.

Family Recovery Housing is a place where parents can live along with their children in their own apartment while learning new skills and building healthy relationships in recovery allowing families to heal together as parents become active in the recovering community.
Home of New Vision	Washtenaw	Men's & Women's MAT Recovery Homes	The MAT Recovery Housing Program serves men and women who are utilizing medication to assist in their recovery from an opiate use disorder. The program provides care navigation to assist the clients in connections to the recovery community, assist with attending appointments with MAT providers, safe storage of MAT medications, and monitoring compliance with taking medication. Care navigation and recovery coaching assists the client in obtaining employment, entitlements, connection and support in the recovery community as well as the program offering safe housing option with individuals who are also in early recovery.
		Opioid Overdose Recovery Team (ROOT)	This program has staff on call 24/7. A certified peer recovery coach is initiated by law enforcement or hospital staff when an individual 18 or over experiences an opioid overdose within Washtenaw County. This program ensures a certified peer recovery coach and/or case manager, meets with the survivor in the local hospital emergency room, within 3-5 hours of admittance to the emergency department. Staff conduct a preliminary recovery plan and a Recovery Capital Scale to address case management and recovery needs.

Peer recovery coaches assist individuals in enhancing recovery support structure, linkage to recovery support groups, and providing assistance in overcoming barriers.

Project ASSERT is a collaboration between LCMHA and St. Joseph Mercy Livingston Hospital. The program is embedding a regular full-time peer support staff in the emergency room with medical staff during peak times when people with substance use disorder present to the hospital. The peer staff support utilizes a non-judgmental approach to engage people with OUD needs after presentation with intoxication, overdose, associated medical risks, etc. Tools such as Screening, Brief Intervention and Referral to Treatment (SBIRT), motivational interviewing and recovery planning will be used. Peer staff will assist people with SUD to directly link with Stepping Stones Engagement Center, LCMHA Access for SUD screening, SUD providers, private providers, recovery community and other supports. Peers can follow these people for engagement after emergency room contact to facilitate successful linking into recovery options. Peers can help to obtain naloxone through Engagement Center and/or Emergency Room.</p>
Marie's House of Serenity	Washtenaw	Recovery Housing	<p>Marie's House of Serenity is a MARR Certified sober living home for women with substance use disorder. Marie's House of Serenity provides education, inspiration and a safe drug free environment to increase potential for long term recovery.</p>

Individuals meet with peer recovery case managers weekly and are assisted with establishing treatment, transportation, healthcare, food, housing, recovery maintenance, employment, parenting skills, continuing education/GED, budgeting, healthy relationships, independent living skills, recovery activities and other needs of the individuals to be successful in their recovery.
		Recovery Housing	Paula's House provides recovery housing, case management and peer recovery support services for women with an opioid use disorder. Priority is given to women using MAT/MOUD. Women participate in outpatient OUD treatment, attend recovery focused support groups, meet with peer recovery coach and case manager weekly, complete random drug screens and complete an array of groups geared towards the women and their individual needs and wants.
Recovery Advocacy Warriors (RAW)	Monroe	Recovery Community Organization	Recovery Advocacy Warriors (RAW) is a Recovery Community Organization (RCO) accredited by the Association of Recovery Community Organizations (ARCO) at Faces & Voices of Recovery. RAW is a peer led organization that provides a participatory process which involves building and providing volunteer opportunities for individuals in recovery, building peer recovery support services in the Monroe community through trainings and volunteer opportunities, increasing access to mutual support meetings that support all pathways to recovery, redefining recovery friendly language and reducing stigma.

Ty's House	Monroe	Recovery Residences	Ty's House provides on-site volunteer Peer Recovery Coaches; limited transportation and job search assistance with supportive employment initiatives, twelve step program initiation and recreational and therapeutic activities. This recovery residence encourages and promotes a recovery oriented, multi-level continuum of care for those in recovery from Substance Use Disorder. Residential care ensures adherence of a set of core values which include ethical standards of practice, operating principles which reflect quality and professionalism, and commitment to recovery-oriented principles of recovery.
Unified HIV Health and Beyond	Monroe Washtenaw	OUD/StUD Recovery	Unified HHB supports and assists People Who Use Drugs (PWUD) by offering services in the form of recovery services, peer recovery coaching, providing bus passes, housing resources, personal care items, linkage with UHHB behavioral health therapist, recovery coach, navigator, and case management. UHHB also focuses on marginalized and underrepresented communities such as LGBTQIA+ youth, youth living with HIV, peer groups and/or family members engaging in substance use, misuse and/or having a SUD.
Paula's House	Monroe	OUD Recovery Housing	Recovery Housing provides case management and peer recovery support services for women with an Opioid Use Disorder. The priority is given to women using medication assisted treatment. Individuals participate in outpatient and OUD treatment, attend 6 recovery focused support groups each week, and meet with a peer recovery coach and case manager weekly.

The programming includes mentoring, nutrition education, cultural activities, community service projects, life skill building and peer support groups that focus on both substance use prevention and recovery. The Adolescent Community Center provides skills needed to allow the ability for participants to change behavior and reduce substance use.
		Anchor Institution	This specific Anchor Institution provides a health hub specifically for Accessing Substance Use/Behavioral Health Program for disparate communities. This Anchor Institution works specifically with African American and Hispanic/Latino/a/x members of the community. The location is within the Family Medical Center of Michigan. Within this location is a kiosk that provides a substance use disorder / behavioral health assessment for participants. This assessment will be presented in English and Spanish. A video series is in the process of creation to assist in reducing the stigma attached to accessing services. A summit will be presented to the community for information and resource sharing, access to services, and linking participants to providers.
